## 表格內採用的名詞及措辭釋義

### Meaning of terms and expressions used in Self-Certification Forms

「居留司法管轄區」- 指某名個人或某實體是某地區的稅務居民的情況下，指該地區。  
“Jurisdiction of residence”-means a territory of which an individual or entity is a resident for tax purposes.

「稅務編號」（包括具有等同功能的識辨編號）-指納稅人的識辨編號或具有等同功能的識辨編號（如無納稅人的識辨編號）。稅務編號是稅務管轄區向個人或實體分配獨有的字母與數字組合，用於識別個人或實體的身分，以便實施該稅務管轄區的稅務法律。有關可接受的稅務編號的更多詳細資訊刊載於經濟合作與發展組織的自動交換資料網站：<http://www.oecd.org/tax/automatic-exchange/crs-implementation-and-assistance/>。

“TIN” (including “functional equivalent”) -means Taxpayer Identification Number or a functional equivalent in the absence of a TIN. A TIN is a unique combination of letters or numbers assigned by a jurisdiction to an individual or an Entity and used to identify the individual or Entity for the purposes of administering the tax laws of such jurisdiction. Some jurisdictions do not issue a TIN. However, these jurisdictions often utilise some other high integrity number with an equivalent level of identification (a “functional equivalent”). Examples of that type of number include –

(for individuals) a social security/insurance number, citizen/personal identification/service code/number, and resident registration number.
